

CONTEST RULES - "J'AIME LE FESTIVAL

1. CONTEST PERIOD

1.1. The Contest begins on May **27, 2026 at 14:00 AM (EST)** and ends on **July 4, 2026 at 11:59 PM (EST)** (the "Contest Period"). The date and time of receipt will determine eligibility.

2. ELIGIBILITY

2.1. Open to **legal residents of the province of Quebec** who have reached the **age of majority** at the time of entry. The Contest is **not open** to employees, agents, or representatives of the Organizer, the Partners, their affiliates, subsidiaries, associated companies, advertising and promotional agencies, promotional partners, product/service providers related to the Contest, or their immediate family members (parents, children, siblings, spouses) or persons living with them.

5. WINNER SELECTION
