1. CONTEST ORGANIZER

The Drive Your Earnings contest is organized by Beneva Inc. ("Beneva").

2. CONTEST PERIOD

The contest is held in Canada and runs from December 1st 2025, at midnight (ET) to March 13, 2026, 4:00 p.m. (ET) ("Contest Period").

3. ELIGIBILITY CONDITIONS

To enter, participants must:

- Be 18 years or older at the time of participation;
- Be a resident of a province or territory in Canada;
- Hold and maintain the appropriate and required certificates and licenses in the Canadian province or territory where they operate;
- Be a broker under contract with Beneva;
- Respect the principles of sound commercial practices and fair treatment of clients.

4. ELIGIBLE PRODUCTS

The eligible products for this sales campaign are all individual investment products offered by Beneva inc.

5. NEW MONEY

Subject to the exceptions provided below, transactions must be subscribed with new money only, meaning money that comes from a new contribution or an external transfer (hereinafter "New Money"). If there is a combination (New Money and renewal), the bonus will be granted proportionally to the New Money. Amounts invested through Preauthorized debits (PAD) are considered as New Money.

Employees, agents, officers, directors, representatives having signed an exclusive distribution agreement with Beneva Inc. or its affiliates, as well as all persons with whom they are domiciled, are excluded from the contest.

11. GENERAL CONDITIONS

- **11.1** To be declared a winner, the participants selected must confirm that they meet the eligibility conditions and other requirements of these contest rules. Failure to comply with any of the above conditions or to accept the prize will result in disqualification of the participant.
- **11.2 Verification.** Entries are subject to verification by Beneva.
